

## Technical Memorandum Update

### Appendix 10 Agency Correspondence

Since the 2007 Approved CE (on attached CD), the proposed transit corridor has been modified along Segment E. Whereas the previous two-way transit alignment followed Clark and Bell Streets, the modified alignment is a one-way pair with southbound service along Clark and Bell Streets and northbound service along Crystal Drive between 26<sup>th</sup> Street and 15<sup>th</sup> Street. Note that the project alignment for the entire corridor is shown in Figure 1: Modified Alignment and CCPY Improvements (Appendix 1 of the current CE Update). Attachment Part A of the Documented CE Update document is a detailed description of the transit alignment in each segment.
